During the year on 25.11.2022 ISO Auditor Mr. Vidyadhar Apshankar did Audit and ISO Certification of Vatsalya was continued for above projects and as well as certification also covered 'Drive with Pride' Project at Kanjur.

ANNUAL INSPECTION

The officials of Mumbai Suburban District Women & Child Welfare Department of Maharashtra State pay visits to the Trust from time to time and inspect the registers maintained by Vatsalya and give valuable suggestions, which are followed immediately. The cleanliness at Vatsalya, quality of food being served to the children was very much appreciated by all of them.

The extraordinary service of the employees was appreciated by giving them 'Employee of the Year Award'. Vatsalya's volunteers Shri. Sadanand Samant, Shri. Avdhoot Gadgil and Ms. Swapna Rajwade were felicitated for their immense contribution.

Thereafter the ISO Auditor Mr. Vidyadhar Apshankar and his colleagues presented a melodious musical orchestra which was thoroughly enjoyed by all and especially by the children.

Ms. Sachita Deorukhkar gave vote of thanks.

Ms. Madhavi Mundhe and Ms. Nanda Sangode compered the function.









ADMINISTRATION

Vatsalya Trust, Mumbai has 11 Trustees. Out of 11 Trustees, 3 Trustees are permanent and the remaining 8 Trustees are substituted after every 6 years. However, 4 Trustees who have completed 6 years in office, retire after every 3 years. The meetings of the Trustees are held at least once in every quarter and minutes of the meeting are recorded. Besides this, the trustees meet from time to time to take important decision. The Trustees take policy decisions and perform to achieve the goals as intended and aimed. In the meetings of the Trustees, significant issues are reported. Any policy decision, if required, is also taken in such meetings.

The meetings of the members of the Managing Committee are held every month. The Managing Committee Members are in charge of the day-to-day work of the Trust. The Trustees and the Managing Committee Members of the Trust do not accept any allowance or honorarium. Since inception of the Trust, it has not incurred any expenditure on any foreign tour.

ORPHANAGE

Child Care (Orphanage) and Rehabilitation (Adoption) Centre

Vatsalya started Child Care and Rehabilitation Centre (Orphanage) for destitute / deserted children (mostly infants) as its first core activity after obtaining the licence from the Government. The Orphanage and Adoption Centre was inaugurated on 02-06-1985.

Orphan children need care, affection, attention, protection and edification. Steady and caring family ambience help them grow better. Identifying this basic need, Vatsalya started Child Care and Rehabilitation Centre which takes care of infant children till they are adopted. In the last 40 years, Vatsalya has given more than 1350 children in adoption to the adoptive families through, its Kanjurmarg and Alibag Centres.







Few highlights of the project:

With total 45 admissions and 28 adoptions/ restorations during the year 2022-23, Vatsalya has maintained highest operational efficacy. Process of adoption are streamlined and currently there are 43 children at Kanjurmarg Centre.

Judicial authorities have been regularly sending unwed mothers and women/ children in distress for care and protection for short durations. Vatsalya rehabilitates such women by providing vocational skills like computer training/ Tailoring- fashion designing etc. during their stay, so that they can become financial independent by having source of income.

Children who are under 'care and protection' (CNCP) with Vatsalya even for a short duration are given school education so that they do not miss out on their academic year due to family problems. Their emotional needs and childhood is well protected during their stay till they are handed over to their parents or guardians.

Considering growing need of adoptions, Vatsalya started another adoption center at 'Alibag' in Raigad district of Maharashtra in 2010. Recently, 100th baby was given in adoption through Alibag Centre.

During the current year, 16 children were admitted and 8 children were given in adoption through Alibag Centre. Presently, there are 12 children at Alibag Centre.

BALIKASHRAM - Home for Destitute Girls

Balikashram of Vatsalya started its journey at Sanpada in 2000 with a view to support destitute girls and for their care and protection. Girls between the age of 6 years and 18 years are admitted by the order of Child Welfare Committee (CWC) as per Juvenile Justice Act, 2015. Vatsalya continues to house them and enables them to complete their education. All children are looked after well and Vatsalya provides for their education, food, clothing, stay, health and medical needs.

At present about 59 girls are residing at Vatsalya's Balikashram. Out of these 47 are in the age group of 6 years to 18 years and 12 are above 18 years. In addition to this Vatsalya provides emergency

shelter to the children in distress for short periods, especially during nights and the duration extending in some cases upto 7 days. During the year such shelter was given to 28 minor girls who were also given counseling during their short stay.

Every girl is encouraged to pursue their education in nearby schools and colleges. In addition to their studies at the school, children are encouraged to learn with the help of the teachers at the Balikashram.





During the year, two girls appeared for HSC examination and scored admirable marks. They are now pursuing BMS degree. Seven girls passed in SSC ie. 10th standard examination and they are pursuing further education and Junior college. Ms. Jana Solanke graduated from Mumbai University and she is now pursuing Law degree.

We are proud of one of our girl Ms. Pooja Rauth who has secured admission for post graduate degree course i.e. MSc in Food Safety and Hygiene Management at the University of Birmingham, UK. Vatsalya has sought financial support from donors for her studies and has obtained assurances.

Ms. Pooja Shinde has cleared MHCET examination and got admitted for Masters in Management Studies (MMS) course.



Academically inclined girls are admitted in colleges to pursue the area of their choice and a few are being put in skill development programs. One girl is trained as a beautician and two are pursuing catering, and one in patient care. Five girls who have been released by CWC after reaching 18 years were supported financially for pursuing their higher education during the current year.

Almost all girls are very good in sports and often excel in sports meets. In the District sports meet organized by DWC in December 2022, children of Vatsalya won several trophies and 41 medals, practically sweeping the laurels.

Overall psychological health of our girls is monitored and necessary counselling is given by our counsellor on a regular basis. Children with emotional instability and behavioral issues are given therapies and motivated for better performance.

In order to inculcate the national spirit and to nurture them to be good and responsible citizens, we celebrated Independence Day, Republic Day, Gandhi Jayanti, Savitri Bai Phule Jayanti and Chatrapathi Shivaji Maharaj Jayanti.

Various festivals are celebrated with fun and frolic to apprise the children of religious and cultural



traits e.g. Navaratri, Ganeshotsav, Kojagiri Purnima, Diwali, Christmas/ New Year Eve. Every child's birthday is celebrated with festivities and enthusiasm.

Volunteers of NGO U&I Foundation take classes during weekends teaching the children basic mathematics as well as mannerisms and communication skills. Events were also conducted by volunteers of Fly Higher.

The During summer break many girls learnt the basics of digital literacy, Yoga and self-defense techniques.

During vacation, the girls spent a day at Arnala beach.

With active support of Mr. Ness Wadia, the co-owner of the IPL Team 'Punjab Kings' and his NGO 'NamMyoho Daan' the children watched two IPL cricket matches at the D. Y. Patil Stadium and at Wankhede Stadium.

Yoga teachers from 'NamMyoho Daan' also conducted regular Yoga classes for the children twice a week throughout the year.

On 17.12.2022 Mr. Ness Wadia visited the Sanpada project and also participated in Havan.

VRUDDHASHRAM:

At Sanpada project Vatsalya also runs a Vruddhashram (Home for aged) along with Balikashram. At Vruddhashram, good care of elderly is taken. They are also provide with television facilities, newspapers, library etc. for their entertainment and relaxation. In the campus of Vatsalya there is a Shree Ganesh Mandir. Counselling and psychological support is given to inmates for balance mental health.





ALIBAG PROJECT

During the year on 7th January 2023, Satya Narayana Puja was organized at Alibag Center. On that occasion, distinguished congregation of the donors and well wishers visited the project.

Dr. Dhamankar, Dr. Aditya Chewle, Dr. Parvez Sheikh and Dr. Saurabh Patil are helping in providing health care to the children.



BADLAPUR PROJECT

During the year Primary Medical Center at Badlapur has catered to the medical needs of the nearing community padas in Bhoj, Badlapur including Dahivali, Juveli, Kondeshwar, Bendshil, Chamtoli, Varada, Dhamangaon.

Diseases such as Eczema, fungal infection, scabies, viral fever, diarrhea, arthritis, and malnourishment is common in the region. Due to severe poverty in the surrounding villages skin diseases and malnourishment is on rise. Besides, due to heavy labor work arthritis is common. During the year Vatsalya has provided free medical aid and treatment to 1106 patients, out of which

794 were women and 312 were men.

A health check-up camp was arranged on 26/02/2023 at the Bhoj center and 103 beneficiaries availed the services at the camp.





O Eye check-up:





With the help from 'Smt. Indirabai Wavikar Charitable Trust', Thane an Eye check-up camp was arranged and the 50 customized spectacles were distributed to the villagers at the nominal cost of Rs.100/-.

O Dental Check-up:



Around 50 patients were provided dental check-up. It was observed that majority of patients had dental diseases such as caries and periodontitis. They were referred to the nearby dentists in Badlapur for their treatment needs.

REHABILITATION CENTRE - for Persons with Disabilities (Divyang)

'Rehabilitation Centre' (RC) supports children with any delay in regular development through children and parent guidance programs with supervised professional

interventions.

The services offered at Vatsalya Trust Rehabilitation Centre include Special Education, Occupational and Physiotherapy, Speech Therapy, Counselling, Group Therapy and Vocational training.

Currently, about 200 children with various disabilities such as Cerebral palsy, Autism, Learning Disability, ADHD (Attention deficit hyperactivity disorders), Angel man Syndrome, Down's syndrome, MR, Hemiplegia,



GDD (Global Developmental Delay) receive services and training at Kanjurmarg, Alibag, Sanpada projects of Vatsalya.

The Professionals at Vatsalya first take the history, background information of the child and provide counseling to the parents regarding the disability, ways of handling, what can be done, etc. Then the child is referred to the various departments of Vatsalya RC, like Physiotherapy, Occupational Therapy, Speech Therapy, Special Education, Group Therapy and Counseling section. All these therapies and treatments are provided at concessional rates. The parents are also given assistance to obtain further concessions if they are from financially weaker background.



Rehabilitation Centre's activities encompass mainly four focus areas:

- Early Intervention (Aakar) Centre which provides facilities like Physiotherapy, Speech and Occupational Therapy, special education to children who are at the risk of developing impairment such as intellectual challenges, developmental delays and language/ speech problems.
- Child and Parent Guidance (Khushi) Centre caters to the need of the children with various challenges such as behavioral, emotional and scholastic. Khushi Centre handles above issues through Psychiatric Intervention, Family therapy, Therapy with Children, Parent's skill training and teacher's sensitization programs.
- Outreach activity (Disha) under which rehabilitation aids and equipment's are provided to special need children by networking with other NGOs.



 Pre-vocational and Vocational Training Under which children with special needs are taught about various self-dependent activities due to which they can contribute themselves economically in their living

All above focus areas/ activities are brought under common platform of 'Rehabilitation Centre (RC)' for providing holistic approach to Rehabilitation of special need children. RC Centre's activities/ processes are also certified for Quality Management System (QMS) Under ISO 9001-2015 by TUV Austria.



Presently, Vatsalya is running Rehabilitation Centers at three locations i.e. Kanjurmarg (Mumbai), Sanpada (Navi Mumbai) and Alibag (Raigad District). About 200 Children with special needs are receiving regular therapy at these Centre's. Under DISHA, outreach program, about 300 children received the support for rehabilitation aids and equipment's during 2022-23. Vatsalya trains parents and care givers of these children for awareness and successful implementation of the treatment plan.

RC-KANJURMARG

Vatsalya Trust, Mumbai started Rehabilitation Centre (RC) for special need children in 2004 at Kanjurmarg. The License under PWD Act 1995 is issued by Apang Aayukatalay (Pune) to Vatsalya.

Since 2005, Rehabilitation Centre at Kanjurmarg has registered more than 2600 and through the team of qualified professionals it is providing therapy/Treatment to about 130 children per week.

Various events were organized during the year.

Functions and Celebrations: To incorporate children with different cultures of the society various events like Summer Camp, Ashadhi Ekadashi, Raksha Bandhan, Independence Day, Gokul Ashtami, Ganesh Chaturthi, Navratri, Diwali, Children's Day, Get Together for children and parents, Sports Day and Holi were organized.

Summer Camp: The sweltering summer days were utilized with a 3 days summer-camp for children attending RC along with their parents.

During year, 38 children benefited from occupational therapy, speech therapy and physiotherapy
The specialists Dr. Manisha Meshram (Physiotherapy), Dr. Rishikesh Deshmukh (Speech Therapy),
Dr. Megha Sheth (occupational therapy) and Ms. Aditi Gokhale (psychologist) gave therapy to the
children.

DISHA (Outreach Centre) - Activities

Vatsalya's outreach program 'DISHA' aims to reach the maximum beneficiaries and support them outside Vatsalya through a network with voluntary Organizations, Professionals and various social institutes.

Orthosis Camp: This year 7 Camps were conducted throughout Maharashtra under 'Disha' outreach program in association with other institutes such as Samvedhana Latur, AWMH, Avishkar Special School Ratnagiri, Bharat Vikas Parishad, Pune Sobati Centre, Wada etc.









- On 22/05/2022 at Pune at Orthosis Camp there were 3 beneficiaries registered for orthosis, basic evaluation and moulds were prepared at Bharat Vikas Parishad. The professional team from Vatsalya included Two OTst Dr. Ankit, Dr. Megha and Orthotician Siddhesh Sir. Followed by distribution of orthosis on 19/06/2022, done by Dr. Ankit, Dr. Hiral and Orthotician Siddhesh Sir during which patients parents were trained regarding the use of AFO.
- Successful distribution of Hearing AIDS and Orthosis was done on 30/6/2022 and 01/07/2022 at Latur during which patients and parents were trained regarding the use of AFO, and hearing aid was conducted.
- 3. DISHA camp for special needs children was conducted successfully on 17.08/2022 and 23/09/2022 at Avishkar Special School, Ratnagiri. Total 90 children were assessed and treatment program was given, out of which 41 were assessed for Occupational Therapy and 49 for Speech Therapy. Also the parents and staff at the Avishkar were explained the treatment program through virtual meeting. OTist- Dr. Hiral and Dr. Megha along with Speech Therapist Ms. Gayatri have taken great efforts in offering rehabilitation services to the children from remotest part.
- On 21/12/2022 at Alibag 34 beneficiaries were assessed and moulds were taken, and distribution camp was also held on 24th February 2023 by Aarambh Speech and Hearing Clinic with the help of Audiologist Rushikesh, Mrs. Aditi and the team at Alibag Centre.
- On 11/03/2023 at Kanjurmarg 19 beneficiaries were assessed and moulds were taken for orthosis, out which 12 children were from AWMH and 5 children attending RC. Successful distribution of orthosis was done on 15th April 2023 during which patients and parents were trained regarding the use of AFO.
- On 20/02/2023 through DISHA 12 beneficiaries were assessed and treatment program was given at Sobati Centre, Wada.
- Basic evaluation and moulds were taken for Hearing Aid for 25 beneficiaries at Kanjurmarg on 24/03/2023 and 30/03/2023. Entire RC team and team from Aarambh Hearing and Speech Clinic took great efforts in the camp.

'Skill to Thrive' project

Patient Assistant Programme.

Genesis of the Issue:

The status of girls' education in the country is a matter of grave concern. As per the National Commission for Protection of Child Rights' 2019 report, almost 40% of girls aged between 15 and 18 years dropped out of the school, out of which more than half of them took up household duties.

Programme brief:

Education especially skill-oriented vocational courses are better option for such drop out girls.



Hence, Vatsalya started 'Patient Assistant Programme' (PAP) affiliated to YCMO University in year 2006 for such drop out girls. The Course is of one year duration and involves theory classes and 4 months of practical training in Hospital. The Girl students in Mumbai underwent practical training in 'Indravati' Hospital (Airoli) and 'Ashwini' hospital in Ghatkopar.

Vatsalya has been providing 'PAP' training at Mumbai, Navi Mumbai, Neral, Latur, Dapoli and in Palghar district. In all 250 girls get trained in these centers every year.

More than 1500 trained girls are so far placed in Hospitals/ nursing homes/ clinics and earning respectable livelihood.

Future Need:

'Health Care Industry' also needs large number of clinical/ diagnostic and other support staff for administering basic care to patients. Home care, geriatric care and extension of health care facilities in rural/tribal India need large pool of trained manpower in health care sector. Hence, Vatsalya started GDA (General Duty Assistant), a 6 months course at Kurla and Dervan to cater to Homecare segment. This is backed with NSDC (National Skill Development Corporation) certification.

In order to augment above efforts, Vatsalya also intends to train Patient care assistants, Aasha Workers, Home care assistants, Geriatric care assistants etc. at various locations in Maharashtra by handholding local NGOs.

Above programme empowers women and instill confidence/self-belief in them.



2. Basic/Advance Beauty and Wellness training

The Vatsalya Trust, Mumbai, started its pioneering empowerment initiative in the field of 'Beauty & Wellness' in August, 2021, aimed at uplifting marginalized communities, particularly women, by providing them with essential skills and opportunities in a thriving industry.

During our efforts to prepare unskilled youth for gainful employment, a significant realization emerged that there exists a keen interest, especially among women from economically disadvantaged backgrounds, to pursue careers in the Beauty industry.

Beauty and Wellness Project: Highlights

" National Skills Development Corporation (NSDC) certified training enables students to learn



skills necessary to thrive in the industry.

- " Vatsalya established training centers in Kurla and Ulhasnagar to impart training. Course covered skills relating to pedicure, manicure, hair/skin care etc.
- " New satellite centers were established at Swayamsiddha Mahila Mandal at Latur, Sevalay at Hasegaon-Latur, Dervan, SPMESM at Sambhaji Nagar and Jalna during current year.
- " Special campaigns were designed to reach out to specific groups, particularly women from economically disadvantaged backgrounds including transgender, sex workers, jail inmates etc.
- " A specialized 'Train the Trainers' programs were conducted to enhance the understanding of Beauty theory for our trainers, led by expert Ms. Savita Pethe.
- Both trainers and students of the Beauty course were encouraged to complete the Basic Computer Course, encompassing MS Office products and email usage in addition to technical skills.
- " Trainees were provided with an overview of Business Financials, while proposals were made for training in Communication skills in English.
 Vatsalya's continuous efforts extend beyond traditional training, focusing on empowerment, holistic development, and inclusive outreach.

Success stories:

- " Vatsalya is happy to state that many of our students have been employed in the private sector or have managed to obtain self-employment assignments and thus have become independent and earning.
- " Our initial goal was to reach 150 beneficiaries by the end of the financial year 22-23, but we surpassed expectations and successfully reached out to and benefited a total of 377 individuals.
- " Vatsalya is associated with an internationally renowned Beauty Experts viz. Ms. Savita Pethe from Mumbai and Ms. Rohini Pande from Aurangabad who are highly motivated to contribute back to the society through their professional expertise. Ms. Savita is guiding Vatsalya in creating and delivering high-quality Beauty education to our trainers. Ms. Pande conducts Career Counseling sessions and workshops for Vatsalya's students.





3. Tailoring and fashion designing

Vatsalya, is pioneering an empowerment initiative in the field of Tailoring and Fashion skills and opportunities in a thriving industry.

Tailoring and Fashion Designing program started in August 2021, aimed at uplifting marginalized communities, particularly women, by providing them with essential training.

Project - Highlights:

- Vatsalya has strategically established training centers across Maharashtra, serving as hubs for comprehensive programs in Tailoring and Fashion Designing. These centers ensure accessibility and widespread impact.
- National Skills Development Corporation (NSDC) certified training enables students to learn skills necessary to thrive in the industry.
- * Students enrolled in the programs benefit from a well-structured curriculum that covers both fundamental and advanced tailoring techniques. This ensures a robust foundation and empowers learners to tackle complex industry demands.
- * Recognizing the importance of industry insights, the Vatsalya has strategically collaborated with accomplished fashion designer Ms. Bharati Kokane. This partnership enables students to gain valuable insights into real-world industry practices and trends, enhancing their professional readiness.
- * Vatsalya's approach extends beyond technical proficiency. Alongside tailoring skills, students receive training in crucial soft skills, computer literacy, effective communication and financial management. This holistic development equips them for success in a dynamic industry.

Success Stories:

Vatsalya set up Training centers at Kurla, Ulhasnagar, Hasegaon-Latur, Jalna, Sambhaji Nagar and Rajapur-Ratnagiri in Maharashtra in 2022.





" Our initial goal was to reach 300 beneficiaries by the end of the financial year 22-23, but we surpassed expectations and successfully reached out to and benefited a total of 458 individuals.



- " Many of the trained candidates have secured employment or self-employment opportunities in the Tailoring and Fashion designing industry.
- On 3/12/2022, Kurla's Tailoring students organized a successful fashion show, showcasing their skills and gaining practical experience. The event exuded professionalism and reflected their journey towards excellence. Notably, the function was graced by over 8 dignitaries who are industry experts, underscoring its significance.
- " Training is being provided to more than 25 jail inmates, ensuring they're socially prepared to earn a living post their jail term. Our programs focus on practical skills and essential life training, aiding their reintegration into society and fostering positive change for a better future beyond incarceration.
- " In November 2022, more than 350 Para- Nursing (PAP) Uniform sets were skillfully stitched by students enrolled in our Tailoring and Fashion Designing course. Under the expert guidance of our dedicated trainers, these students not only gained valuable industry experience but also contributed to their financial well-being by utilizing their newly acquired skills. This accomplishment showcases the tangible impact of our training programs in empowering individuals and creating practical opportunities for them to earn income.

4. E-vidya Digital Literacy Program

E-vidya program is run by Vatsalya to promote digital training in smaller towns and rural areas.

We were giving offline training from Kanjurmarg, Sanpada and Kurla centers. Vatsalya has started 46



number of E-vidya centers in different parts of Maharashtra and Goa. This is achieved through a collaborative effort with other local NGOs and Educational Institutions. We have trained 1872 students in different job oriented courses in FY 22-23.

Vatsalya has training centers which are registered with MKCL and MSCIT and KLIC courses are being conducted. Vatsalya has also started to impart training in collaboration with NIIT Foundation and has also started its own NSDC training partnership process.

288 students were trained at Vatsalya in Collaboration with NIIT Foundation sponsored by Syntel and 70

students got job in Syntel Company itself.

In another project with NIIT Foundation sponsored by Angel Broking, 30 students completed their advance course training like Digital Marketing, BFSI and Logistics.

Sessions were also conducted to train the student to improve communication skills and to confidently face job interviews which were immensely beneficial for them.



Vatsalya intends to spread E-vidya in collaboration with target of 50 institutions and 3000 students during the coming academic year to help children and youth from weaker section of the society and rural areas of India where spread of computer education is limited.

Vatsalya started training students from Rajnandini School, Kauthale, Pandharpur where the student base is predominantly children of Brick workers. In the NSDC basic computer training examination Ms. Mrudula Badke of 9th standard stood first scoring 94%.



Drive with Pride

Drive with Pride project was conceived in year 2016-17 We have been regularly training candidates in 2/3/4 wheeler training. Lately we have also started JCB / POCLAIN Driving training at latur and sambhaji nagar. During the year 2022/23 broad classification of candidate trained in various catagories is as below

2 wheeler - 4

3 wheeler-90

4 wheeler - 175

JCB construction equipment vehicle: 12

Total: 281

Vatsalya Trust, Mumbai had collaborated with 7 different NGOs throughout various locations in Maharashtra such as Solapur, Latur, Beed, Satara, Islampur, and Sangli to conduct various driving training program as mentioned above

A glance of DWP project at various locations:

In a unique enterprise, Vatsalaya Trust in collaboration with Sarathi Youth foundation, Solapur trained 15 women on Auto-rickshaw. These women were workers in the tobacco industry, and it was essential to provide them an alternate occupation – and we were successful for the same.



Empowering Transgender Population



Vatsalya Trust, in an initiative to work for the welfare of the Transgender population so as to make them self reliant. The training and license have opened new avenues for them to get out of the stigmatized profession. "I thank Vatsalya Trust, Mumbai for helping me out in getting trained and obtaining a LMV-TR license," says Sumon. (Transgender)

JCB Construction Vehicle Training, Latur



In collaboration with Sevalay, Latur 12 beneficiaries were trained on JCB construction equipment vehicle. The idea behind this initiative was to provide well-trained operators on heavy vehicles to support the demand on these workers in the construction/logistics industry. Adding to it, this training is a residential one so as to support the needy people.

E-vehicle Training of waste collectors at Janadhar, Latur

A batch of 30 women who are waste collectors in the city of Latur have been given a helping hand by Vatsalya Trust, Mumbai in collaboration with an NGO – Jan - adhar to get trained on E-Vehicles. These E-Vehicles are a modified version of 3wheelers and waste collectors are undergoing training on it. After getting trained, these beneficiaries would be operating the garbage collecting vehicles on their own thus giving a steady rise in their daily income finally improving their quality of life.





KURLA PROJECT

A Primary School Building was taken on rent from Bhagini Mandal Kurla in June 2021. Our Udan Project in Kurla Started there. This Centre is dedicated to Skill development.

We have started courses like Computers (Digital Literacy), Beauty and Wellness, Tailoring & Fashion Designing, Mobile Repairs. We intend to train marginalized youth in job Oriented Courses. We have Trained 267 Beneficiaries in 2022-23 and target to train 500 Students during the 2023-24

Several Programs were arranged during the year.

Fashion show was organized on 03/12/2022. In the fashion show, the students displayed innovative and stylish clothes by wearing the clothes designed themselves. The chief guest of the show was Mr. Ashraf Azmi, Municipal Corporator of Kurla West, as well as Police Inspector Mr. Maruti Patil Sir, Ms. Suvarna Sonwane Madam, Coordinator of Women Economic Vikas Maha Mandal, Ms. Pratibha Kamble Madam, Coordinator of Kotak Education Foundation, Fashion Designer Ms. Namrata Kokane and Ms. Khyati Kulkarni graced the function.



International Women's Day was celebrated by at the Kurla Project on 10.03.2023. Local corporator Shri Ashraf Azmi, social worker and PSI Ms. Varsha Bhagat and PSI Ms. Nutan Patil, Ms. Kunjale and Ms. Rajshree Damle of Kurla police station were present on this occasion. Skill sale activities are implemented through the organization. On this occasion, the students presented a drama entertainment program. Ms. Rajshree Damle guided the students to build their confidence. Mr. Ashraf Azmi promised to help the students for entrepreneurship.


